- e. To equip the students to overcome the cultural, language and communication barrier issues.

### **3. Roles and responsibilities**

- c. IIBM shall provide opportunity for BCMS students to interact and engage with students of IIBM by arranging workshop, Management games etc. in mixed teams.

- e. IIBM shall arrange organizational visit and outing for two days.
- f. BCMS shall pay the expenses for the programme as mutually agreed; based on per head.


